Article 2:

The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis: This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the General Corporation Law of Idaho. Said corporation is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) , to wit: Providing educational material about other charitable organizations via our site on the internet and allowing the members, for a \$1 monthly donation to vote on the recipient of the combined monthly donation. The potential donees will be vetted by the officers of the corporation to ensure they are qualified non-profit entities and voting members will be apprised each month of not only the candidates and their organizations but also of the previous months' outcomes and what kinds of donations, including but not limited to goods, services and man hours have been achieved.
