## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned being of full legal age and a citizen of the United States, has this day voluntarily formed a corporation under the laws of the State of Idaho, and hereby adopts Articles of Incorporation as follows:

Ι

The name of the corporation shall be CROWN NUCLEAR, LIMITED.

The term of existence of the corporation shall be perpetual.
