Designate, constitute and appoint BOYD HAMILTON, residing in the City of Coeur d'Alene, in said County of Kootenai, and State of Idaho, as the Authorized Agent of said Corporation in the State of Idaho, upon whom process issued by authority of, or under any law of, the State of Idaho, may be served, as provided by the constitution and laws of said State;

2. Revoke the designation of said E. Duerselen as such authorized Agent aforesaid; and

3. Direct that this certificate and designation when properly executed and acknowledged by and on behalf of said

Interstate Telephone Company Limited, in duplicate, be duly filed in the State of Idaho, in the offices of the Clerk of the District Court in and for said County of Kootenai and of the Secretary of State, according to the statute in such case made and provided.
