# AMENDMENT TO ARTICLES OF INCORPORATION

OF And B Commission

That as of March 16, 1984, the following amendment to the Articles of Incorporation of Henry's Lake Village, Inc. was consented to and authorized by the unanimous written consent of the holders of all of the issued and outstanding stock of said corporation entitled to vote, in accordance with the provisions of Section 30-146(5) of the Idaho Code.
