

ARTICLES OF INCORPORATION OF THE ADVANCE PUBLISHING  
COMPANY, (LIMITED).

KNOW ALL MEN BY THESE PRESENTS; That we the undersigned citizens of the City of Pocatello, Bannock County, State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho, and we certify the following facts, to-wit:--

First.

That the name of said Corporation is the ADVANCE PUBLISHING COMPANY, (LIMITED),

Second.

That the purpose for which it is formed is to carry on the business of editing, printing and publishing a news-paper in the City of Pocatello, and to do printing, binding, advertising, and all kinds of printing work, job work, binding and other skilled mechanical work in and about well equipped news-paper and printing establishments.

Third.

That the place where its principal business is to be carried on and transacted, shall be the City of Pocatello, Bannock County, Idaho,

Fourth.

That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth.

That the number of its directors shall be five, and that the names of those who are appointed for the first year, and their residences, are:---
