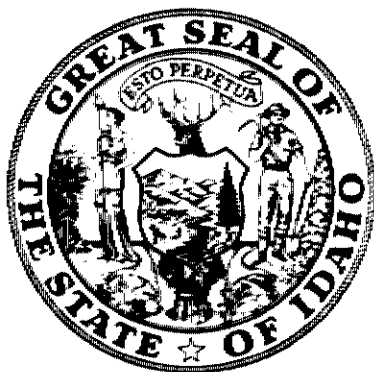

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, and being collectively all the shareholders of issued and outstanding stock of **CACTUS FLATS, INC.**, have amended the original Articles of Incorporation dated September 30, 1988, and in support thereof submit the following Articles of Amendment:

I.

The name of the Corporation is **CACTUS FLATS, INC.**

ARTICLE II.

The amendment so adopted is as follows:

Article I. of the original Articles of Incorporation is amended to read as follows:

The name of the Corporation shall be **DESERT DESIGNS, INC.**

ARTICLE III.

The amendment of the Articles of Incorporation was adopted by unanimous vote of the shareholders at a meeting held Friday, June 23, 1989.

ARTICLE IV.

The total number of shares issued and outstanding of Cactus Flats, Inc. is 500. All such shares were entitled to vote on the adoption of the amendment.

ARTICLE V.

At the meeting of shareholders held Friday, June 23, 1989, 500 shares were voted in favor of the amendment and 0 votes voted against the same.

ARTICLE VI.

The foregoing amendment affects a change in the name of the Corporation
