

Articles of Incorporation.

Art. 1st.

This certifies that we the undersigned have this day formed a Company for the purpose hereinafter specified and which shall be known as the Snake River Valley and Reservation Canal Company, with such powers and privileges as are allowed Corporations under the Laws of Idaho.

Art. 2.

The purpose for which this Company is formed is to take Waters out of Snake River in Bingham County and State of Idaho and convey the same by canal and laterals from a point at or near the S.E. corner of lot 7, in Section 31, Tp. 1 N.R. 37 E. B.M. on said Snake River, to and over all lands available south and southwestwardly to the Blackfoot and Snake Rivers, thence across the Blackfoot River to and over the Fort Hall Indian Reservation to the town of Pocatello, in Bingham County Idaho, for the purpose of using or disposing of the same for Agricultural, mining, domestic and other useful purposes; to purchase claims and hold real estate so far as may be necessary for the purpose of a corporation, and to sell and convey the same all of which as is provided by Law.

Art. 3.

The place where the principal business shall be transacted shall be Idaho Falls, Bingham County, Idaho.

Art. 4

The term of Existence ~~of this~~ corporation shall be fifty years from the date hereof.

Articles of Incorporation.

Art. 1st.

Art. 2.

The purpose for which this Company is formed is to take Waters out of Snake River in Bingham County and State of Idaho and convey the same by canal and laterals from a point at or near the S.E. corner of lot 7, in Section 31, Tp. 1 N.R. 37 E. B.M. on said Snake River, to and over all lands available south and southwestwardly to the Blackfoot and Snake Rivers, thence across the Blackfoot River to and over the Fort Hall Indian Reservation to the town of Pocatello, in Bingham County Idaho, for the purpose of using or disposing of the same for Agricultural, mining, domestic and other useful purposes; to purchase claims and hold real estate so far as may be necessary for the purpose of a corporation, and to sell and convey the same all of which as is provided by Law.

The place where the principal business shall be transacted shall be Idaho Falls, Bingham County, Idaho.

Art. 4
