ARTICLES OF INCORPORATION

The undersigned, acting as Incorporater under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE ONE  
Name

The name of the Corporation is P I F, INC.

ARTICLE TWO  
Purposes

The purposes of the Corporation are: To have and to exercise all the powers now or hereafter conferred by the Laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE THREE  
Duration

The duration of the corporation is perpetual.

ARTICLE FOUR  
Location

The location of the registered office of the corporation in the State of Idaho, is: S. 3737 Ebert Road, Coeur d'Alene, Idaho 83814, and the registered agent is Grant Stowe.

ARTICLE FIVE  
Stocks

The total authorized number of par value shares of stock is 25,000, and the aggregate par value of the shares is TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00). The total authorized number of shares without par value is ZERO (0). The stock of the corporation is all common stock having equal voting rights and preferences.

Shares of stock in this corporation shall not be transferred or sold until the sale or transfer shall have been reported to the Board of Directors and approved by the Board. The Corporation shall have first option to repurchase any stock so offered.

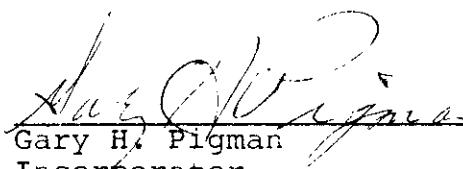

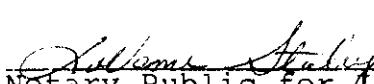
