ARTICLES OF INCORPORATION OF
IDAHO MICA REPEATER ASSOCIATION INCORPORATED

The undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Idaho, do hereby certify:

1. The name of the Corporation shall be called the Idaho Mica Repeater Association, Incorporated.
2. Said association is organized exclusively for charitable, scientific, literary, or educational purposes, that qualify as exempt organizations under Section 501 (C) (3) of the internal Revenue Code of 1954 (or the corresponding provisions of any future U.S. Internal Revenue Law).
3. The period of duration of this association shall be perpetual.
4. To help establish and maintain a network of links to other repeaters in the 4 northern counties of Idaho and the North Idaho Repeater Association Inc. of Kootenai County.

This Association is organized to provide Radio Repeaters for the use by the Amateur Radio Emergency Services, for public service and the Kootenai County Civil Defense through the Radio Amateur Civilian Emergency Services Program.
5. The association/ corporation shall consist only of a Board of Directors with fee users members.

No part of the net earnings of the association shall inure to the benefit of, or be distributable to, its Board of Directors, or their private persons, except that the association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of the association shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and the association shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the association shall not carry on any other activities not permitted to be carried on (A) by a corporation exempt from Federal Income Tax under Section 501 (C) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future U.S. Internal Revenue Law) or (b) by a corporation contributions to which are deductible under Section 170 (C) (2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future U.S. Internal Revenue Law).
