The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, per as follows:

#### ARTICLE I

The name of the corporation is Ichivan Trading, Inc., (hereinafter "Corporation").

## ARTICLE II

The purposes for which this Corporation is organized are as follows:

- 1. To engage in the production of agricultural products; and,
- 2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE III

The Corporation shall have perpetual existence.

#### ARTICLE IV
