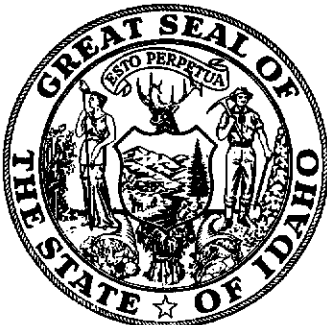

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the President and Secretary respectively of KREUDER & AGEE, P.A., an Idaho corporation, do hereby certify as follows:

That KREUDER & AGEE, P.A. is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That at the Special Meeting of the Shareholders and Directors of KREUDER & AGEE, P.A. held on the 30th day of August, 1995, at the hour of 12:00 o'clock p.m. of said date, at 404 East Elm Street, Caldwell, Idaho, at which said meeting a majority of the Shareholders of said corporation were present, a majority of the shareholders voted to adopt the name of "Surgical Associates, P.A.", but that name was not available. That on the 20th day of September, 1995, a Resolution was regularly proposed, voted upon and adopted by a majority of all of said Shareholders amending the Articles of said corporation, since the name of "Surgical Associates, P.A." could not be used, the number of shares outstanding and entitled to vote on said Amendment were 1,000, and all of them voted in favor of said Amendment, and that the following is a full, true and correct copy of the Resolution of said Shareholders amending the Articles of said corporation, to-wit:

" RESOLUTION

BE IT RESOLVED, That the Articles of Incorporation of KREUDER & AGEE, P.A. be and the same are hereby amended as follows:

Article I is hereby amended to read in its entirety as follows:

ARTICLE I

That the name of this corporation shall be
"THE SURGICAL GROUP, P.A."


BE IT FURTHER RESOLVED, That the corporate officers execute Articles of Amendment to Articles of Incorporation and duly file said Articles of Amendment with the Secretary of State of the State of Idaho and any other governmental agency that is required."

That said Resolution of the Shareholders was approved on the 20th day of September, 1995, by a majority vote of the Shareholders of said corporation.

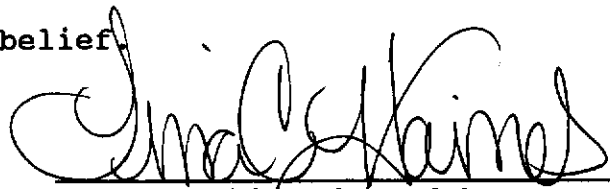
