ARTICLES OF INCORPORATION

SECRETARY OF STATE OF IDAHO

The undersigned, acting as incorporators of PRESCOTT REFRIGERATION, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PRESCOTT REFRIGERATION, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(A) To carry on a refrigeration business for profit dealing with both refrigeration repairs and installation.

(B) To carry on any other kind of business or business activities that the Board of Directors may from time to time deem to be advisable or proper in connection with the business.

(C) To transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
