

DESIGNATION OF AGENT
AND ACCEPTANCE OF THE PROVISIONS OF THE
CONSTITUTION OF THE STATE OF IDAHO.

KNOW ALL MEN BY THESE PRESENTS, That the UTAH MORTGAGE LOAN CORPORATION, a corporation organized and existing under the laws of the State of Utah, having filed in the office of the Secretary of State of the State of Idaho a duly authenticated copy of its Articles of Incorporation, and having also filed therein its designation of JOHN C. GREAVES residing at Preston in the County of Oneida as authorized agent of said corporation in said State of Idaho upon whom process issued by authority of the State of Idaho might be served, and having therein designated Oneida County in the State of Idaho as the County in which the principal place of business of said corporation in said State would be conducted, in pursuance of the laws of the State of Idaho, makes this certification and does hereby change the principal place of business of said corporation from Oneida County, State of Idaho, to Ada County, State of Idaho, and does hereby designate Ada County in the State of Idaho as the County in which the principal place of business of said corporation in said State of Idaho is and shall be situated, and does hereby revoke the appointment of the said John C. Greaves as such authorized agent; and does hereby designate O. O. HAGA, residing at Boise in said Ada County as authorized agent of said corporation in said State of Idaho upon whom process issued by authority of or under any law of the State of Idaho may be served, as pro-

vided by the Constitution and laws of said State of Idaho.

And the said UTAH MORTGAGE LOAN CORPORATION, desiring and intending to conform in all respects to the Constitution and laws of said State, and to avail itself of the rights, privileges and immunities guaranteed by said Constitution and laws, does hereby accept the provisions of the Constitution of the State of Idaho for all the intents and purposes contemplated by the provisions thereof, relating to such acceptance by other than municipal corporations. (Article XI, Section 7, Constitution of Idaho).

IN WITNESS WHEREOF, the said UTAH MORTGAGE LOAN CORPORATION has caused this Certificate and Acceptance to be executed, acknowledged and delivered in its name and on its behalf, by its President, and to be attested by its Secretary, and has caused its corporate seal to be hereunto affixed at Logan, in the County of Cache, and State of Utah, this 22nd day of May, 1913.
