ARTICLES OF INCORPORATION

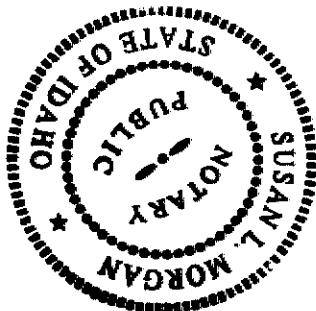


