The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following Articles of Incorporation to the Secretary of State.

ARTICLE I

The name of the corporation shall be: Care First Hospice Foundation Inc.

ARTICLE II

The purpose for which the corporation is formed shall be:

Care First Hospice Foundation Inc. is a nonprofit corporation that is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including for such purposes, the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, this nonprofit corporation is organized and operated to provide relief to the poor, distressed, and underprivileged, by actively soliciting donations from the public for the purpose of assisting families that lack the funds necessary to pay for hospice services, and provide monetary assistance and support to individuals who are in dire need of medical aid through donating medical supplies, hospice services, and other necessary equipment to help cure, treat, and provide necessary remedial care.

Purpose of Obtaining Tax-Exempt Status: No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

ARTICLE VII

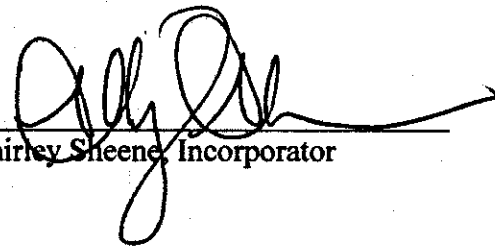
The corporation does not have voting members.
