The undersigned, being duly licensed to practice the profession of dentistry in the State of Idaho, desires to form a professional corporation pursuant to the Idaho Professional Service Corporation Act for the purposes of rendering dental and allied services, and hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME

The name of the Corporation is Alpine Dental Associates, P.A.

ARTICLE II PURPOSE

The purpose or purposes for which the Corporation is organized is to engage in the general practice of dentistry and allied services.
