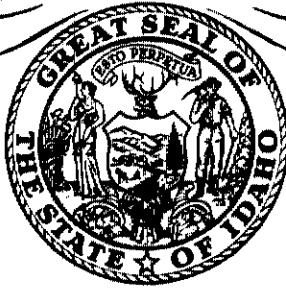

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Twenty-eighth** day of **November**, 19 **61**, original articles of amendment, as provided by Sections **30-146 and 30-147, Idaho Code**, **changing corporate name to CHRISTIAN VISION ASSOCIATION**,

Pursuant to instructions from the Secretary of States office in the form "excerpts from the Idaho Code relative to filing articles of amendment" we, the undersigned, submit the following information:

1. At a regular business meeting of the United Grace and Truth Evangelical Association, Inc., a motion was made, seconded and passed by unanimous consent of the Board of Directors that the following amendment be made to the constitution and by-laws of the said corporation to change the name thereof.

The amendment - "That the name of the non-profit corporation known as The United Grace and Truth Evangelical Association, Inc., be changed and known henceforth as the CHRISTIAN VISION ASSOCIATION".

2. Also, pursuant to instructions from the Secretary of States office such action was published in the Meridian News-Times for four (4) consecutive weeks; such proof of publication is herewith attached.
