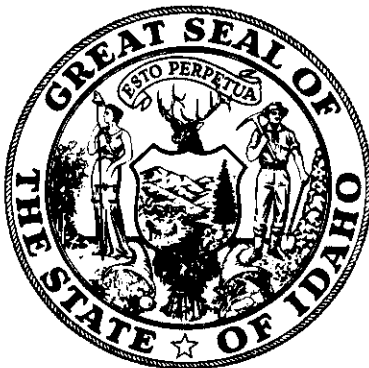

ARTICLES OF INCORPORATION

SECRETARY OF STATE

PALOUSE EMPIRE AMMUNITION, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Idaho.

ARTICLE I. NAME

The name of this corporation is PALOUSE EMPIRE AMMUNITION, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To purchase, lease, or otherwise acquire lands and buildings in this state or elsewhere, for the erection and establishment of a manufactory or manufactories and workshops with suitable plant, engines, motors, machinery, and equipment with a view to manufacture, buy, sell, import, and export, or otherwise deal in or with, as distributors and retailers, any of the wares, merchandise, or goods which this company may lawfully manufacture or deal in.

The purposes of this corporation shall include but not be limited to repairing, manufacturing, jobbing, distributing, buying and selling sporting goods, ammunition, firearms and other sundry items.

To conduct and carry on its business or any branch thereof in any state or territory of the United States or in any foreign country in conforming with the laws of said state, territory, or foreign country, and to have and maintain in any state, territory, or foreign country a business office, plant, or store.

The investment of funds in real estate, mortgages, stocks, bonds or any type of other investments.

14 ARTICLE IX. AMENDMENT

15 These Articles of Incorporation may be amended in the manner  
16 provided by law. Every amendment shall be approved by the Board of  
17 Directors, proposed by them to the stockholders, and approved at a stock-  
18 holders' meeting by Sixty-Six and two-thirds percent (66 2/3%) of the stock  
19 entitled to vote thereon, unless all the directors and all the stockholders sign  
20 a written statement manifesting their intention that a certain amendment of  
21 these Articles of Incorporation be made.

22 ARTICLE X. TRANSFER OF CAPITAL STOCK

23 No stockholder shall sell or transfer his stock in the corporation  
24 without the unanimous approval, at a stockholders' meeting specifically called  
25 for such purpose, of all stockholders of the corporation; provided, however,  
26 that the shareholders may adopt By-Laws providing for the purchase or  
27 redemption by the corporation of its shares.
