KNOWN BY ALL MEN THESE PRESENTS, That we, the understands being natural persons of legal age, and citizens of the present of States, do hereby associate ourselves together with the fire of forming a corporation under and pursuant to the laws of the of Idaho, and we hereby certify:

I.

The name of this corporation shall be NOMAD PACKS & OUTDOOR EQUIPMENT, INC.

II.

The nature, objects, and purposes for which this corporation is formed shall be:

- a. To make, produce, manufacture, prepare, fabricate, finish or otherwise create various types of goods, products and components, and to sell, trade, exchange, let or lease, or otherwise market, within or without the State of Idaho, such goods, products and components;
- b. To acquire, buy, own, hold, sell, exchange, let or lease personal property within or without the State of Idaho;
- c. To borrow money for the purposes of this Corporation, to issue bonds, notes, and debentures and other evidences of indebtedness therefore and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of the corporation may be pledged, mortgaged or hypothecated;
- d. To build any or all buildings, structures, warehouses, or erect the same involved in the said business, building materials, fuel, and to acquire the same by purchase, lease or otherwise;
- e. To purchase, lease, or otherwise, acquire in whole or in part, the business, good-will, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to be conducted by this corporation, or owning property necessary or suitable for its purposes and to pay for the
