Be it remembered that on this 5th day of August, 1916, this matter coming on for hearing at which time appeared H. C. Edwards of counsel for the above named applicant, The Twin Falls Townsite Company, and the Court having inspected the record finds that the notice required by statute and the orders of this court has been given by the clerk of this court by publication in the Deseret News, a newspaper published at Salt Lake City, Utah, for a period of Thirty (30) days and further finds that no objections to the application for the dissolution of said corporation has been filed or in any manner brought to the attention of the court.

Whereupon the Court proceeded to hear and determine said matter and being fully advised in the premises finds that the statements contained in said application are true; that at a meeting of the stockholders of said corporation called for that purpose, duly and legally held at the office of said corporation in Salt Lake City, Utah, on the 5th day of June, 1916, the dissolution of the corporation was resolved upon by a two thirds vote of all the stockholders; that all claims and demands against said corporation have been settled and discharged; that the business for which said corporation was formed has been fully carried out and completed and that it is the desire of said stock holders as expressed at said meeting and the board of directors, that said corporation be dissolved.

It is therefore by the court ordered, adjudged and decreed that the corporation heretofore existing under and pursuant to the laws of the State of Utah known and designated as the Twin Falls Townsite Company, be and the same is hereby declared to be dissolved, and the same is now dissolved according to the statutes of the State of Utah.
