# ARTICLES OF INCORPORATION MAY 1 A. U

OF

JOHN KENT PIKE, M.D., P.A.

The undersigned, JOHN KENT PIKE, who is over the age of twenty-one (21) years and is legally authorized to practice medicine in the State of Idaho, associates himself for the purpose of forming a professional corporation under the laws of the State of Idaho, and adopts the following Articles of Incorporation:

# ARTICLE I

#### Name

The name of the corporation is JOHN KENT PIKE, M.D., P.A.

#### ARTICLE II

# Principal Office and Registered Agent

The principal office of the corporation in the State of Idaho is 1107 Ironwood, Coeur d'Alene, Idaho 83814. The registered agent at this address is John Kent Pike, M.D.

#### ARTICLE III

#### Duration

The corporation shall have perpetual existence.

# ARTICLE IV

# Purposes

The purpose of this corporation is to engage in every phase and aspect of the practice of medicine and surgery under the laws of the State of Idaho; provided such medical services shall be rendered only through the directors. officers, employees and agents of the corporation, all of whom must be legally authorized to practice medicine in the State of Idaho.

# ARTICLE V

#### Capitalization

The aggregate number of shares of which the corporation shall have authority to issue is 50,000 shares of common stock, each of a par value of \$1.00.

#### ARTICLE VI

# Commencement of Business

The corporation will not commence business until consideration of the value of at least \$500.00 has been received for the issuance of shares.

#### ARTICLE VII

# Regulation of Internal Affairs

Provisions for the regulation of the internal affairs of the corporation, including provisions restricting the transfer of shares, are:

No shares of the capital stock of the corporation shall be issued to anyone other than an individual who is legally authorized to render services as a medical doctor in the State of Idaho.

No shareholder of this corporation shall sell or transfer any of his shares in the corporation except to another individual who is eligible to be a shareholder of this corporation, and then only in accordance with procedures set forth in the By-Laws of the corporation for such sale or transfer. Any shares transferred to any person or entity ineligible to be a shareholder, whether such transfer be voluntary, involuntary, or by operation of law, shall be redeemed or cancelled by this corporation.

No shareholder of this corporation shall enter into any voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

If any Directors, Officer, Shareholder, Agent or Employee of this corporation becomes legally disqualified to render services as a medical doctor in the State of Idaho, he shall immediately sever all employment with, and financial interest (other than interests as a creditor, if any) in this corporation.

# ARTICLE VIII

#### Directors
