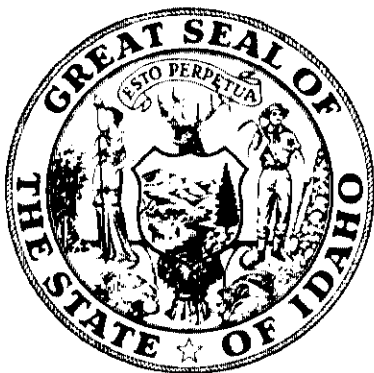

ARTICLES OF INCORPORATION

MOUNTAIN VIEW BAPTIST CHURCH, CORPORATION, OF BLACKFOOT

ARTICLE 1. NAME AND INCORPORATION

The name of the corporation will be Mountain View Baptist Church, Corporation, of Blackfoot; South Riverton Road, P.O. Box 488, Blackfoot Idaho 83221. This church is a perpetual non-profit Corporation which was duly Constituted March 23, 1986.

ARTICLE 2. PURPOSE

The purpose of this corporation shall be the regular worship of God according to the precepts and examples of the church of our Lord Jesus Christ as set forth in the New Testament, to sustain ordinances and doctrines, and to preach and propagate among all people of the world the Gospel of God's Salvation by personal faith in Jesus Christ as Savior and Lord.

ARTICLE 3. MANAGEMENT

The management of this corporation is vested solely in the body of the members who compose it, pursuant to Idaho Code section 30-314(c).

ARTICLE 4. BOARD OF DIRECTORS

There is no board of directors, the management of this corporation is pursuant to Article 3. of this document.

ARTICLE 5. LOCATION OF CORPORATION

The location of the Corporate Office is South Riverton Road at the Mountain View Baptist Church, three miles south of the city of Blackfoot, adjacent to Interstate-15.

ARTICLE 6. REGISTERED AGENT

The registered agent for this Corporation will be the Pastor, THOMAS MENDEZ, residing at the parsonage which is adjacent to Mountain View Baptist Church on South Riverton Road.
