# ARTICLES OF AMENDMENT CEIVED

AT A MEETING OF THE GEM STATE GROTTO, INC. ON DECEMENT 1980, THE FOLLOWING ARTICLES OF AMENDMENT WERE ADOPTED BY A UNANAMOUS VOTE OF A QUORUM OF THE MEMBERSHIP.

#### ARTICLE X

This corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

#### ARTICLE XI

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from the Federal income tax under Section 501 (c) (3) of the Internal Revenue Code.

### ARTICLE V

That, inasmuch as this corporation is a non-profit association, there shall be no capital stock, but membership certificates may be issued in such form and manner and subject to such regulation as the by-laws of the corporation may prescribe. The voting power or membership, and the constitution of a quorm for all meetings, shall be subject to regulation by the laws of the State of Idaho. It's revenue shall be from contributions and dues. Upon termination and/or dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code. This article superceeds ARTICLE V of the original Articles of Incorporation of the Gem State Grotto, Inc.
