ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being natural persons of legal age and acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is FOSTER AGRO INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

Section 1: Description of Classes of Stock. There shall be two classes of stock.

Section 2: Number of Shares. The aggregate number of shares which the corporation shall have authority to issue is fifty thousand shares (50,000), with a par value of One Dollar (\$1.00) per share. This corporation shall have authority to

issue thirty thousand (30,000) shares of non-voting, non-cumulative preferred stock and twenty thousand (20,000) shares of voting common stock.

Section 3: Voting Rights and Preferences. Each voting common share shall have equal voting power; each voting common share shall entitle the holder to one vote; non-voting preferred shares shall have no voting power. Upon liquidation, there shall be no preference.

FIFTH:

The address of the initial registered office of the corporation is Route 2, Box 84, Rigby, Idaho, 83442, and the name of the initial registered agent at such address is Brad Foster.

SIXTH:

The number of directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders, or until their successors are elected and shall qualify are:
