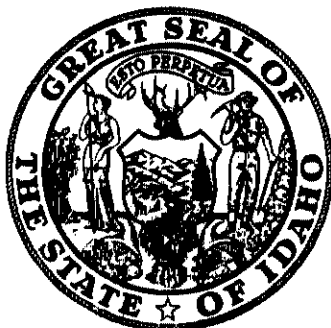

ARTICLES OF INCORPORATION

Pursuant to the Idaho Non-Profit Corporation Act, the undersigned, of legal age, adopts the following Articles of Incorporation:

1. The name of the corporation is EAGLE MINISTRIES INC.
2. This corporation is a nonprofit corporation.
3. The period of its duration is perpetual.
4. The purposes for which it is organized are:
 - (a) To engage in activities exclusively for charitable, religious, and education purposes, including teaching and preaching the gospel of Jesus Christ, evangelism, musical performances, and ministering to individuals confined in hospitals and institutions, as well as ministry to the general public.
 - (b) To conduct Christian fellowship groups, religious retreats, periodic classes for teaching the word of God.
 - (c) In furtherance of the foregoing purposes, to make distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue law).
 - (d) To engage in any activity consistent with these Articles of Incorporation and not prohibited by the Idaho Non-Profit Corporation Act.
5. The corporation has members.

6. The corporation has members, and the management of its affairs is vested in these members pursuant to section 30-314(c), Idaho Code.

7. This corporation is organized exclusively for charitable, religious, and educational purposes as a non-profit corporation, and its activities shall be conducted for those purposes in such a manner that no part of the income or property of the corporation shall inure to the benefit of any non-charitable organization, or any director, officer, or individual. The corporation shall not engage substantially in carrying on propaganda or otherwise attempting to influence legislation, nor will the corporation carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended (or the corresponding provisions of any future United States Internal Revenue law) or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Revenue law).









