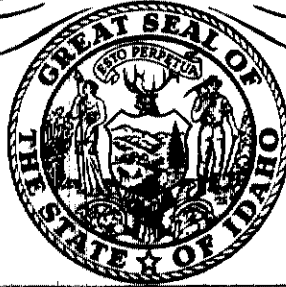

One Thousand Nine Hundred **Sixty-eight** and is ^{to be} duly recorded on ~~Film No.~~ **microfilm** Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Perpetual Existence** from the date hereof, with its registered office in this State located at **Idaho Falls, Idaho** in the County of **Conneville** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

KNOW ALL MEN BY THESE PRESENTS: That hwereas, pursuant to notice duly given as provided for in Section 30-1102, Idaho Code, to-wit: by publication of such notice for two weeks in The Post-Register, a newspaper published in the County of Bonneville, State of Idaho, the first publication being made on the 28th day of April, 1968, and the last publication being made on the 5th day of May, 1968, and by the posting of a like notice in a conspicuous place at the church building at 1275 Bingham Ave., Idaho Falls, Bonneville County, State of Idaho, where said election was held, a meeting was duly held at the time and place specified in such notice by the members of that church and congregation known as the Community Church of God on the 12th day of May, 1968, at the hour of 7:30 o'clock, P.M., at the church building, 1275 Bingham Ave., Idaho Falls, Bonneville County, Idaho, for the holding of an election for trustees of said church to incorporate and thereafter operate said church under and in conformity with the provisions of Section 30-1101, Idaho Code, at which meeting a majority of the members of said church and congregation who were present voted at such election, and whereas, it was determined by a majority of the votes cast at such election to incorporate said church and operate in conformity with Section 30-1101, Idaho Code, and the undersigned were duly elected and authorized at such election to act as incorporators of said church and to incorporate the same.

NOW, THEREFORE, we, the undersigned, duly authorized to do so, as foresaid, do hereby associate ourselves together on behalf of said church, for the purpose of forming a religious corporation pursuant to Chapter 11 of Title 30, Idaho Code, and to that end do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I

The name of this corporation shall be "COMMUNITY CHURCH OF GOD, Inc."

ARTICLE II

The location and post-office address of this corporation shall be at 12 75 Bingham Ave., Idaho Falls, Idaho.

ARTICLE III

Purpose and Powers

The purpose of this Church is to organize a communion of Believers in our Lord and Saviour Jesus Christ, and to manifest His redemptive Gospel to all peoples.

The corporation shall have power to establish and maintain a place or places of worship and teaching for the meetings of the church, and to buy, sell, hold, receive title to such real and personal property as may be necessary or useful for the business and objects of the corporation, by devise, gift, grant or other conveyances, to mortgage or otherwise encumber its property, and any part or portion thereof, to carry on educational and charitable work, to conduct a church and church services and functions, and to advance the principals of Christianity.

The congregation shall have the sole power to call its own pastor and leader and to contract with him for his services.

ARTICLE IV

Membership

Any person may become a member of this corporation, subject to such regulations and restrictions as may be prescribed in the by-laws of the congregation.

ARTICLE V

Management

The promotion, operation and maintenance of the corporation together with the management of church property and real estate shall be under the control of a Board of Trustees of the corporation,

1 consisting of not less than five (5), nor more than one hundred
2 (100) members, to be elected and to hold office for such term and to
3 exercise such powers as may be prescribed in the by-laws. The first
4 Board of Trustees shall consist of the members elected at said meet-
5 ing held on the 12th day of May, 1968, being the following named
6 persons, to-wit:

12 By-Laws

13 By-laws shall be made and adopted by the Board of Trust-
14 ees for the government and internal management of the corporation,
15 subject, however, to final approval by the members of the congrega-
16 tion.

17 ARTICLE VII

18 Meetings

19 There shall be one regular annual meeting of the corpora-
20 tion for the transaction of all business relating to the corpora-
21 tion, to be held at such time and place as may be prescribed in the
22 by-laws, and such other special meetings of the corporation as the
23 Board of Trustees shall call from time to time. Notice of all meet-
24 ings shall be given as prescribed in the by-laws.

25 ARTICLE VIII

26 Duration

27 The duration of this corporation shall be perpetual.

28 ARTICLE IX

29 Amendments

30 These Articles of Incorporation may be amended in manner
31 and form as authorized by law, by a majority vote of the members of
32 the corporation present and voting at any regular or special meeting

1 of the corporation, provided, however, that due notice of the pro-
2 posed amendment shall have been first given as prescribed in the
3 by-laws.



3 FLORENCE BRELAN, being first duly sworn on oath, deposes
4 and certifies as follows:

5 That pursuant to notice duly given and provided for by
6 Section 30-1102, Idaho Code, a meeting of the members of that church
7 and congregation known as the Community Church of God, formerly the
8 Church of God in Christ, was held at the time and place specified in
9 said notice, to-wit: On the 12th day of May, 1968, at the hour of
10 7:30 o'clock, P.M. at the church building in Idaho Falls, Bonneville
11 County, Idaho, for the holding of an election for trustees of said
12 church and congregation to incorporate the same and operate under
13 and in conformity with the provisions of Section 30-1101, Idaho Code.

14 That due and regular notice, in writing, of the holding
15 of said meeting at the time and place aforesaid was given by publi-
16 cation thereof in The Post-Register, a newspaper published in Idaho
17 Falls, Bonneville County, Idaho, for two weeks, the first publica-
18 tion being made on the 28th day of April, 1968, and the last publi-
19 cation being made on the 5th day of May, 1968, and by posting of a
20 like notice in a conspicuous place on the building where the said
21 meeting was held, to-wit: the church building at 1275 Bingham Ave.

24 That due proof of such publication appears on record in
25 my office as secretary of said meeting and of said corporation, by
26 the affidavit of the printer and publisher of said newspaper, and
27 that due proof of such posting of said notice appear by the Affidavit
28 of Ellie D. Parrish, both of said affidavits being on file and of
29 record in my said office.
