E. The amount of cash and the other property contributed to the partnership is set forth on Schedule A of the Partnership Agreement and the initial capital accounts is set forth in Article V of the Partnership Agreement.

F. Partners with negative capital accounts shall be liable to restore them from any source including the capital items or capital receipts distributed to them by the partnership.

G. Any Limited Partner shall have the right to assign his Limited Partnership interest by giving thirty (30) days advance written notice to the General Partners. Any such assignment shall be effective only to give the assignee the right to receive the share of profits to which the assignor would otherwise be entitled and shall not give the assignee the right to become a substituted limited Partner except with the written consent of the Partners.

Η. A General Partner may not assign or otherwise transfer his or her interest as a General Partner without the affirmative majority vote of the other partners. A Limited Partner, or his successor, may withdraw from the partnership at will by giving the partners thirty (30) days advance written notice. Upon withdrawal, a Limited Partner or his successor shall have the right to require the Partnership to pay, in equal monthly installments over a period of three (3) years; an amount equal to the fair market value of his Partnership interest, including Partnership goodwill, if any. No Limited Partner shall have the right to demand or receive property other than in cash in return for his Partnership interest. Each monthly installment shall include interest at the prime rate for commercial banks in Northern Idabo determined at the time the Partnership interest is withdrawn. If the General Partners and the withdrawing Limited Partner or a successor in interest of a deceased Limited Partner fail to agree on the fair market value of the withdrawing Limited Partner's interest, the valuation shall be determined by arbitration in accordance with the rules of the American Arbitration Association then in effect.

No partner shall have the right to demand or receive Ι. property other than in cash in return for his partnership interest.

J. No Partner has the right to receive, nor does the General Partner have the right to make, distributions to a partner which includes a return of all or any part of the partner's contribution.

K. The Limited Partnership shall be terminated after twenty-one (21) years or earlier upon the death, bankruptcy, disability or resignation of the sole remaining General Partner. The Limited Partnership may be voluntarily dissolved by the majority vote of the partners.
