



CERTIFICATE OF AMENDMENT OF ARTICLES OF

RUSSELL STOVER CANDIES, COPPLETION Dept. SECRETARY OF STATE

The undersigned, Russell Stover Candies, Inc., a Missouri corporation (hereinafter called the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with the provisions of The General and Business Corporation Law of Missouri, does hereby make and execute this Certificate of Amendment and does hereby certify as follows:

I. The name of the Corporation is:

RUSSELL STOVER CANDIES, INC.

The Corporation was originally organized under the name of Business Ventures, Inc.

- II. The amendment set forth below was adopted by the share-holders of the Corporation at the Annual Meeting of the Shareholders of the Corporation held on December 19, 1977.
- III. The following resolution sets forth the amendment adopted:

RESOLVED, that the Articles of Incorporation of this corporation, as heretofore amended, be and they hereby are, further amended by deleting the present ARTICLE SIXTH thereof and by inserting in lieu thereof the following new ARTICLE SIXTH:

ARTICLE SIXTH

The number of directors to constitute the present board of directors of this corporation is nine (9). The number of directors to constitute subsequent boards of directors shall be fixed by, or in the manner provided in, the bylaws of the corporation. Any changes in the number of members of the board of directors shall be reported to the Secretary of State of the States of Missouri within thirty (30) calendar days of such change. Directors need not be shareholders of the corporation.

- IV. The number of shares of stock outstanding and the number of shares entitled to vote on the foregoing amendment was 6,533,000 shares of Common Stock, with par value of \$1 per share.
- V. The number of shares of Common Stock of the Corporation voted at said meeting for the said amendment was 5.57.554 shares and the number of shares of Common Stock of the Corporation voted at said meeting against said amendment was 7.892 shares.
- VI. In accordance with the provisions of The General and Business Corporation Law of Missouri, the foregoing amendment was adopted by the affirmative vote, at said meeting, of a majority of the outstanding shares of stock of the Corporation.
