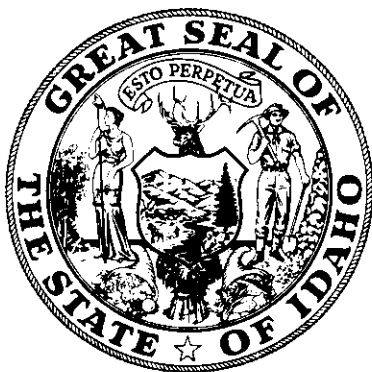

ARTICLES OF INCORPORATION

MONTEVIEW CHRISTIAN CHURCH, INC. OF MONTEVIEW, ID.

We, the undersigned, being natural persons of full age and citizens of the United States, who are associated together as a church, not for pecuniary profit, hereby incorporate ourselves under the Idaho Nonprofit Corporation Act of the State of Idaho ( 30-301ff. I.C.)

ARTICLE I

The name of the corporation shall be Montevue Christian Church, Inc. of Montevue, Id.

ARTICLE II

This corporation shall not issue stock and no dividends or pecuniary profit shall be declared or paid to the members thereof.

ARTICLE III

Subject to dissolution in the manner provided by law, the duration of the corporation shall be perpetual.

ARTICLE IV

The purposes for which the corporation is organized are:

- A. To bring all men into a personal relationship with the Lord Jesus Christ as their personal Saviour.
- B. To conduct religious worship and to provide a place therefor.
- C. To establish, maintain and conduct a school, (pre-school through college ) for religious and academic education.
- D. To preach and teach the Whole Council of God, as set forth in the Old and New Testaments of the Holy Bible, to its members and to the community.

E. To promote the spiritual, moral, intellectual and physical growth and well-being of its members and of the communities in which they reside.

F. To promote a spirit of brotherhood between the members of the corporation and respect for the individual freedoms to all men.

G. To receive gifts of money and property of every kind and to administer the same for religious, charitable, educational and civic purposes.

H. To own real estate, in the furtherance of the purposes herein stated; to improve the same and to construct church buildings, parsonages, libraries, gymnasiums, schools, camp and retreat facilities and playgrounds thereon.

I. To buy, sell, manage, lease, convey, or encumber such property as may be necessary to carry out the purposes stated herein and to execute such contracts, deeds, mortgages, notes, or other instruments as might be necessary therefor.

J. To do any and all other things necessary in furtherances of the purposes hereinbefore stated, not inconsistent with the corporation laws of the State of Idaho.

#### ARTICLE V

This corporation is to be made up by its members.

#### ARTICLE VI

The management and business affairs of the corporation shall be conducted by a board of directors, to be known as a board of trustees, which shall consist of not less than three persons, each of whom shall be a member of the corporation.

#### ARTICLE VII

An election of such officers,(trustees) was held on Dec. 30, 1980, at 7:30 p.m. in Montevue, Idaho. A majority of the members of said church who were present at the meeting at which such election was held voted in said election, which voting resulted in the election of the first board of trustees,of; Rev. Charles W. Hill,

Katherine Nick, Dean Wadsworth, and Rosalee Wadsworth. The secretary is Yvonne Wadsworth.

#### ARTICLE VIII

The location and post office address of the registered office of the corporation shall be Wadsworth Road, Montevue Idaho 83435 (Jefferson County) and its registered agent at such office is Rev. Charles W. Hill
