### CERTIFICATE OF INCORPORATION

was filed in the office of the Secretary of State on the **nineteenth** day of **February** A. D. One Thousand Nine Hundred **Forty-five** and **on film roll** is duly recorded in ~~Book~~ **No. 4** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 29-103 and Sections 29-1001 to 29-1005, inclusive, Idaho Code, Annotated.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **fifty (50) years** from the date hereof, with its registered office in this State located at **Buhl** in the County of **Twin Falls** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION  
OF  
BUHL CHAMBER OF COMMERCE

We, the undersigned, all of whom are citizens of the United States and residents of the State of Idaho, and whose post office address is Buhl, Twin Falls County, State of Idaho, do, for the objects and purposes hereinafter stated, and in order to form a corporation pursuant to the laws of the State of Idaho, hereby associate ourselves together and certify as follows:

ARTICLE I.

NAME. The name of this corporation shall be the Buhl Chamber of Commerce.

ARTICLE II.

PURPOSE. The purpose for which this corporation is formed is to further honest and competent administration of public affairs and to promote the various business and commercial interest of the State of Idaho in general, and of the City of Buhl in particular, and to cultivate a spirit of fraternal friendship and social intercourse among its members.

ARTICLE III.

PLACE OF BUSINESS. The principal place of business of this corporation shall be Buhl, Twin Falls County, State of Idaho.

ARTICLE IV.

TERM OF EXISTENCE. The term of existence of this corporation shall be fifty years from and after the date of the certificate of

incorporation issued by the Secretary of State.

ARTICLE V.

DIRECTORS. The number of directors of this corporation shall be twelve, and the directors selected for the first year of the corporation's existence are Frank Squires, Glen Buckendorf, Jack Winkler, and W. M. Studebaker, all of whose addresses are Buhl, Idaho. The directors shall elect officers of the corporation at the first meeting of the board after incorporation.

ARTICLE VI.

NON-PROFIT CORPORATION. This corporation is not organized for profit or pecuniary gain, and shall not issue any capital stock.

ARTICLE VII.

MEMBERSHIP. The initial membership of this corporation shall be the signers of these articles of incorporation, together with others not named herein.

ARTICLE VIII.

BY-LAWS. The corporation shall adopt a set of by-laws in conformity with the laws of the State of Idaho immediately upon the issuance by the Secretary of State of a certificate of incorporation, and the organization of the board of directors.


