ARTICLES OF INCORPORATION

Articles I Name

The name of this corporation shall be the Pine-Featherville EMS, Inc. 19

Article II Office, Address, and Registered Agent

Article III Non-Profit Organization

The Pine-Featherville EMS is a non-profit organization, not charging membership dues or fees for it's services.

Article IV Purpose

The purpose of this corporation shall be to provide emergency care for ill and injured persons and to perform rescue-extrication when necessary within the geographic limits for response as defined by the Chief of the Emergency Medical Services (EMS) Bureau of the State of Idaho.

Article V Board of Directors

The Pine-Featherville EMS shall have no Board of Directors.
