ARTICLES OF INCORPORATION NELSON'S DeLUXE CLEANERS, INC. * * * * * KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify: Τ That the name of this corporation shall be NELSON'S DeLUXE CLEANERS. INC. II That the purposes for which this corporation is formed are: To maintain, operate and conduct a dry-cleaning plant and to do and perform all and every kind of dry-cleaning work and services, finished and unfinished, including the cleaning, pressing, spotting, repairing and any and all other work incidental thereto for the trade at retail and wholesale of wearing apparel, clothes and fabrics of any kind, and all business incidental thereto. To maintain, operate and conduct a coin-operated laundromat, including the maintenance and operation of coin-operated washing machines, drying machines, ironers and also coin-operated vending machines for soap, bleach, softeners, soft drinks, coffee, milk, candy, cigarettes, and all other similar machines appertaining or used in connection with such laundromat; to maintain, operate and conduct a laundry plant and to do and perform all and every kind of laundry work and services, wet wash, rough dry, finished and unfinished and any and all owrk incidental thereto for the trade at retail and wholesale; and to dry clean and renovate wearing apparel, clothes and fabrics of any kind for hire, and all business incidental thereta To purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands and leaseholds, and any interests, estate and rights in real property, and any personal or mixed property. erty, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed. To borrow money, and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of

all kinds, whether secured by mortgage, pledge or otherwise, without limit as to amount, and to secure the same by mortgage, pledge or otherwise, and generally to make and perform agreements and contracts of every kind and description. To manufacture, buy, sell, trade and deal in all and every kind of material, equipment, supplies, product, manufactured or unmanufactured, iron, steel, wood, brick, cement, granite, stone and other products and materials, to buy, acquire, hold, use, empby, mortgage, convey, lease and dispose of patent rights, letters patent, processes, devices, inventions, trademarks, formulas, good will and other rights. To carry on any other lawful business whatsoever which may seem to the corporation capable of being carried on in connection with the above, or calculated, directly or indirectly, to promote the interest of the corporation or to enhance the valuation of its property. III Subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual. That the principal place of business, registered office and the location and postoffice address of the registered office of said corporation shall be 505 1st Street, Idaho Falls, County of Bonneville, State of Idaho. The total authorized capital stock of said corporation shall be FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000.00), divided into Five Hundred (500) shares of the par value of ONE HUNDRED AND NO/100 DOLLARS (\$100.00) each, and all of said stock shall be common stock. VI The number of directors of said corporation shall be four (4), to be elected annually. VII The board of directors shall have the power to repeal and amend the by-laws of the corporation and adopt new by-laws at any meeting of the board of directors. All by-laws shall be subject to -2amendment, alteration and repeal by the stockholders at any annual meeting or at any special meeting called for such purposes.
