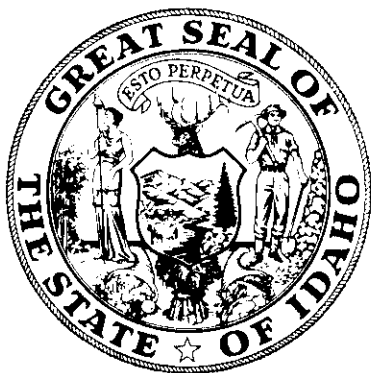

ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all full-age citizens of the United States and of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I.

Corporate Name

The name of this corporation shall be Pegasus, Inc.

ARTICLE II.

Place of Business

The said corporation is organized at, and the place of its general business shall be at Bancroft, Caribou County, State of Idaho.

ARTICLE III.

Period of Existence

The existence of said corporation shall be perpetual or until otherwise dissolved or disincorporated, pursuant to law.

ARTICLE IV.

Corporate Purposes

The purposes for which this corporation is organized is the transaction of any or all lawful business for which corporation may be incorporated under the laws of the State of Idaho.

ARTICLE V.

Capital Stock

The capital stock of this corporation shall consist of 10,000 shares of stock with a par value of \$1.00 per share for a total authorized capitalization of \$10,000.00. All of the capital stock of this corporation

shall be common stock and shall be non-assessable.

The officers of this corporation shall consist of a board of not less than five directors, a president, a vice president, and a secretary-treasurer.



ARTICLE VII.




