## ARTICLE ONE

## ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares of common stock with no par value.

## ARTICLE FIVE

#### ARTICLE SIX

The corporation will not commence business until it has received for the issuance of shares consideration of the value of at least Two Hundred Dollars and No Cents (\$200.00) consisting of money, labor and property actually received.
