The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

Name. The name of the corporation is DALCO CONSTRUCTION, INC.

ARTICLE TWO

Purposes. The purpose of the corporation is to engage and operate a general contracting and construction business for the construction and fabrication of metal and/or conventional buildings and other structures. The corporation may further engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE

Duration. The period of duration of this corporation is perpetual.

ARTICLE FOUR

Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of

Idaho is Mahoney Meadows Building, Suite 880, Highway 95 and "A" Street, City of Plummer, County of Benewah, State of Idaho 83851. The name of the corporation's initial registered agent at such address is Dallas Cook.

ARTICLE FIVE

Stock. The total authorized number of par value shares of stock is One Hundred Thousand. The aggregate par value of the total authorized number of par value shares is \$100,000.00.

ARTICLE SIX

Transfer of Stock. In case a stockholder desires to sell his or her shares of stock, the stockholder must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in this purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his or her stock shall file notice in writing of the stockholder's intention with the secretary of the corporation, stating the terms of sale, and unless the stockholder's terms are accepted by any or all other stockholders within thirty (30) days thereafter, they shall be deemed to have waived their privilege of purchasing and the stockholder will be at liberty to sell to anyone else.

ARTICLE SEVEN
