ARTICLES OF INCORPORATION

OF

J.R. OPTICS, INC.

An Idaho Corporation

- 1. The name of the corporation is : J.R. UPTICS, INC.
- 2. The purpose for which this corporation is tormed is:
 - (a) Primarily to engage in all aspects of activity concerning the manufacture and sale of eyeglass frames, and;
 - (b) To engage in any business related or unrelated to that described in clause (a) of this Article that is from time to time authorized by the Board of Directors of the corporation;
 - (c) To act as partner or joint venturer or in any other legal capacity in any transaction;
 - (d). To do business anywhere in the world;
 - (e) To have and exercise all rights and powers from time to time granted a corporation by law.

The above clauses shall not be limited by reference to or interence from one another, but each purpose clause shall be construed as a separate statement conterring independent purposes and powers upon the corporation.
