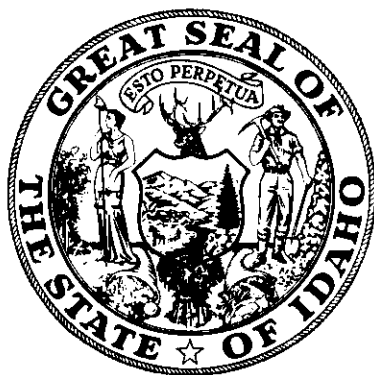

ARTICLES OF INCORPORATION  
OF  
DENNIS A. FRIEDER, D.D.S., CHARTERED

KNOW ALL MEN BY THESE PRESENTS:

That I, DENNIS A. FRIEDER, D.D.S., duly licensed to practice dentistry, of legal age and a citizen of the United States of America do hereby incorporate under and conformable to the laws of the State of Idaho, and particularly under Chapter 13, Title 30, and do hereby make, execute, adopt, publish and certify the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be:

DENNIS A. FRIEDER, D.D.S., CHARTERED

ARTICLE II

It shall be the purpose of this corporation to engage in the profession of dentistry and all services that are included within the field of dentistry; and further to invest its funds in real estate, mortgages, stocks, bonds or any other type of investment including profit sharing and retirement plans, and to own real or personal property necessary for the rendering of professional services, all as more specifically provided for in Idaho Code §30-1307.

ARTICLE III

The duration of the existence of this corporation shall continue until dissolved by law or otherwise.

#### ARTICLE IV

The location and post office of the corporation's registered office shall be at 181 First Avenue North, Ketchum, ID 83340, and P. O. Box 309, Sun Valley, ID 83353, respectively. The registered agent at the above address shall be DENNIS A. FRIEDER, D.D.S.

#### ARTICLE V

The capital of this corporation shall consist of 100 shares with no par value and this stock shall be the only class of capital stock of the corporation; stock may be issued from time to time for such consideration for labor and service, money or property as may be fixed by resolution from time to time by the board of directors of the corporation. No shareholder may sell or transfer his shares except to another individual who is eligible to be a shareholder of such corporation. No capital stock of this corporation may be issued to anyone other than an individual who is duly licensed dentist in the State of Idaho.

#### ARTICLE VI

The board of directors of this corporation shall consist of one (1) member, that being the number of members of the corporation.
