ARTICLES OF INCORPORATION
OF
BETTER BUILT COACHES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons and of full age and citizens of the United States and of the State of Idaho, by these presents associate ourselves together for the purpose of forming a corporation pursuant to the corporation laws of the State of Idaho, and we do hereby certify as follows:

I

That the name of the corporation is Better Built Coaches, Inc.

II

That the corporation is formed for the following purposes:

To engage in the manufacture, repair and remodeling of automotive coaches and buses, house trailers and road trailers, and trucks and accessories, and all articles pertaining to the motor coach, automobile and trailer industry, the assembling of the same, and the sale and lease of such manufactured and remodeled products, and for the purpose of conducting the manufacturing and repair business; to buy, sell and hold real and personal property in any state or territory necessary for the proper conduct of its business, and to do such other things and for such other and further powers as are necessary and incidental to carrying out the general manufacturing and repair business of the corporation.

To engage in the manufacture, application and installation and sale of floor covering material for use in motor vehicles, homes, business establishments and buildings in general.

To acquire by purchase, lease or otherwise, to equip, maintain and operate a general machine shop, and to repair, manufacture, remodel and redesign motor vehicles of every kind, nature and description.

To exercise all authority conferred upon corporations by Section 30-114, Idaho Code, and, in addition thereto, to purchase its own stock and to enter it upon its books as treasury stock or to cancel it or re-issue it and in general to deal and trade in its own stock.

III

The corporation is to have perpetual existence, subject only to dissolution in the manner provided by law.

IV

The location and postoffice address of the registered office of the corporation is 402 Washington Street, P. O. Box 248, Twin Falls, Idaho.

V

The amount of the total authorized capital stock of this corporation is Five Hundred Thousand (500,000) shares having a par value of Twenty Cents (20¢) per share, and shall be all of the same class. Such stock may be issued from time to time without action by the stockholders for such consideration as may be fixed from time to time by the Board of Directors, and shares so issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock.

VI

The private property of the stockholders of the corporation shall not be subject to payment of the corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation or for any other reason. ✓

VIII

The number of Directors of the corporation shall be as specified in the By-Laws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws, providing the number of Directors of the corporation shall not be less than three. In case of any increase in the number of Directors, the additional Director may be elected by the Directors then in office and the Director so elected shall hold office until the next annual meeting of the stockholders and until their successors are elected and qualified. ✓

The Board of Directors is expressly authorized to repeal and amend the By-Laws of the corporation and to adopt new By-Laws, and the corporation reserves the right to amend, alter, change and repeal any provision contained in these Articles of

Incorporation in the manner now or hereafter prescribed by law by a majority vote of the shareholders represented in person or by proxy at any annual meeting of the shareholders or at any meeting duly called for that purpose, except where the laws of the State of Idaho otherwise provide.
