That the KENDRICK-JULIAETTA COMMUNITY DEVELOPMENT ASSOCIATION, INC, a nonprofit group does hereby form a nonprofit corporation under and pursuant to the laws of the State of Idaho under the provisions of Chapter 3, Title 30 of the Idaho Code, entitled Nonprofit Corporations and does hereby certify as follows:

# **FIRST**

The corporate name of this nonprofit corporation shall be KENDRICK-JULIAETTA COMMUNITY DEVELOPMENT ASSOCIATION: THE.

#### SECOND

This nonprofit corporation is organized exclusively for as a business league to administer funds for community development within the within the meaning of Section 501 (c) (6) of the Internal Revenue Code.

#### THIRD

The purposes and objects for which said corporation inasfar as consistent with Section 501 (c) (6) of the Internal Revenue Code is formed are as follows:

- (a) to promote the maintenance and improvement of infrastructure both hard and soft, including communications, cultural events and education in the Kendrick-Juliaetta Area,
- (b) to promote the retention and expansion of existing business in the Kendrick-Juliaetta Area,

- (g) to make, perform and carry out contracts and agreements for any lawful purpose to the extent permitted by an organization exempt from Federal income tax under Section 501 (c) (6) of the Internal Revenue Code,
- (h) to transact any and all lawful business for which nonprofit corporation may be incorporated under Idaho Code Chapter 3, Title 30.
- (i) to comply fully with Section 501 (c) (6) of the Internal Revenue Code and not to carry on any activity not permitted by an organization exempt from Federal Income Tax under Section 501 (c) (6) of the Internal Revenue Code.

#### FOURTH

This corporation shall have perpetual existence.

#### PIFTH

#### SIXTH

issue any capital stock. No individual shall have any interest whatsoever in the assets of the corporation.
