

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Westergard Transfer & Storage Co.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation by written consent in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation shall be changed to Westergard Management, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was ten thousand (10.000); and the number of shares entitled to vote thereon was ten thousand (10,000).
