# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GEM COUNTY SENIOR CITIZENS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the President and Secretary respectively of GEM COUNTY SENIOR CITIZENS, INC. an Idaho Corporation, do hereby certify as follows:

That GEM COUNTY SENIOR CITIZENS, INC. is a corporation duly organized and existing under and by virture of the laws of the State of Idaho;

That at a special meeting held in Emmett, ID on 8/12/86 in accordance with the provisions of Section 30-146,30-147 and 30-148, Idaho Code, that the following is a resolution which was regularly proposed, voted upon, and adopted by two-thirds vote of all Board of Directors present, amending the Articles of Incorporation correct copy of the resolution of said membership amending the Articles of Incorporation, towit:

#### RESOLUTION

BE IT RESOLVED, that Articles of Incorporation of GEM COUNTY SENIOR CITIZENS, INC. be and they hereby are amended as follows:

## ARTICLE II

A. To establish and provide responsible services, such as Nutrition, Transportation, Social Activities, Referrals to other Social Services (Housing, Health, Homemaker, Social and Rehabilitation Services, Social Security, Legal Aid) to the aged (60 years old and over) citizens of Gem County, Idaho. This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

### ARTICLE XIII

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
