Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporations Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation shall be changed from T & T Drywall, Inc., to Quesnell Construction Company, Inc.

SECOND: That the principal business of the company shall be business and residential construction as opposed to the more limited area of drywall installation.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares voting in favor of such was 100.




