The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1. The name of this corporation shall be WEST MAGIC CARE CENTER, INC.

ARTICLE 2. The term for which said corporation shall exist shall be in perpetuity.

ARTICLE 3. The corporation is organized for the principal purpose of providing health care services and may engage in all activities which are authorized under the Idaho Business Corporation Act, §§ 30-1-1, I.C.
