

CERTIFICATE TO THE AMENDMENT TO THE ARTICLES OF INCORPORATION
OF THE
AMERICAN COMMANDER MINING & MILLING COMPANY, LIMITED,

We, the undersigned Chairman and Secretary of the stockholders meeting, called for the purpose of amending the Articles Of Incorporation of the American Commander Mining & Milling Company, Limited, and a majority of the directors of the said corporation, do hereby certify:

1.

That, at a special meeting of the Board of Directors of the above named corporation, it being a corporation duly organized and existing under and by virtue of the laws of the State of Idaho, held at the principal place of business of the company, near Mullan, Idaho, on March 19, 1925, by a majority vote of the directors of said corporation, to-wit: J. A. Glowe, E. B. Kingsbury, Walter H. Hansen, J. L. McCormick, and Herman Marghardt, a special meeting of the stockholders of said corporation was duly called to be convened and held on April 25, 1925, at two o'clock P. M. of said day, at the principal place of business of the said corporation, near Mullan, Idaho, for the purpose of considering the proposition as to so amend the Articles of Incorporation as to make its stock forever non-assessible.

2.

That notice of the time and place of said meeting, and the object thereof, as aforesaid, was published in the Weekly Press-Times a weekly newspaper published in the City of Wallace, County of Shoshone, State of Idaho, in which said county the principal

place of business of said corporation is located, for a period of at least thirty days; the first publication thereof being the issue of said newspaper dated the 20th day of March, 1925, and once a week thereafter for each consecutive week thereafter, for the full period of thirty days, and until the 24th day of April, 1925, the date of the last publication thereof. And that in addition to such publication, a copy of such notice was personally served upon each of the stockholders of said company by mailing a full, true and correct copy thereof to each of said stockholders at their respective addresses, as shown by the stock book of such corporation, at least thirty days prior to the date of said proposed meeting, to-wit, April 25, 1925.

That said notice contained a copy of the resolution proposed to be adopted, and apprised the stockholders of the fact that it was proposed at said meeting to so amend the articles of incorporation of the company as to make its stock forever non-assessible.

4.

That pursuant to said notice the said stockholders meeting convened and was held at the mine office of the company, it being the principal place of business of the company, near Mullan, Idaho, on April 25, 1925, at which meeting there were present and duly representing more than two-thirds of the entire capital stock of said corporation, to-wit; Eight Hundred Seventy-eight Thousand, Seven Hundred Sixty nine (878,769) shares; J. A. Glowe was then and there elected chairman of said stockholders meeting, and Herman Marquardt was elected secretary thereof, and thereupon by a vote of Eight Hundred Seventy eight Thousand, Seven Hundred Sixty nine shares of stock, the same being all

the stock represented at the meeting, and more than two-thirds of the entire capital stock of the corporation, the following resolution was adopted, to-wit:

"BE IT RESOLVED, that the Articles of Incorporation of this company be amended by the adoption and addition of the following section, to-wit:

Section _____. The stock of this corporation shall hereafter be non-assessible.

BE IT FURTHER RESOLVED, that this amendment shall not become effective until after the final decision of the case of Henry Seyberth, plaintiff, versus American Commander Mining & Milling Company, Limited, defendant, by the Supreme Court of Idaho, and for a period of thirty days after the remittitur in said case is received by the Clerk of the District Court at Wallace, Idaho.

BE IT FURTHER RESOLVED, that the President and Secretary of the corporation be and they hereby are authorized and directed to make, execute and cause to be filed the necessary certificates and other documents in the office of the Recorder of Shoshone County, Idaho, and in the office of the Secretary of State of the State of Idaho, to make this amendment effective, and take such action as soon as possible after the final decision of the said case of Seyberth vs. American Commander Mining & Milling Company, Limited, and in any event within said period of thirty days after the filing of the remittitur as aforesaid."

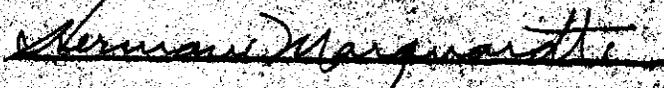
