Pursuant to the provisions of section 30-147 of the Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation presently is GLASS GM DIESEL ENGINE CO.
2. The following amendment of the Articles of Incorporation was adopted by all of the shareholders of the Corporation on May 1, 1969, in the manner prescribed by Idaho Code Section 30-146(5):

THAT THE NAME OF THE CORPORATION BE CHANGED TO  
GLASS DETROIT DIESEL, INC.

3. There were 401 shares of the single class of stock outstanding at the time the shareholders of the Corporation adopted the above Amendment to the Articles of Incorporation and the number of shares entitled to vote was 401.
4. The number of shares voted for the above Amendment to the Articles of Incorporation was 401. There were no shares voting against the Amendment.
5. The Amendment to the Articles of Incorporation does not change the stated capital of the Corporation.
