ARTICLES OF INCORPORATION

OF

SHAUGHNESSY DISTRIBUTING COMPANY, INC.

The undersigned, acting as the Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is Shaughnessy Distributing Company, Inc.

II.

The period of its duration is perpetual.

TIT.

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The street and mailing addresses of the initial registered office of the corporation is 600 Bell Drive, Ketchum, Idaho (83340), and Post Office Box 142, Sun Valley, Idaho (83353), respectively, and the name of its initial registered agent at such addresses is Donald J. Shaughnessy.

v.

The aggregate number of shares which the corporation shall have authority to issue is Fifty Thousand (50,000) all of which shall be common stock with a par value of One Dollar (\$1.00) per share, to be held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.
