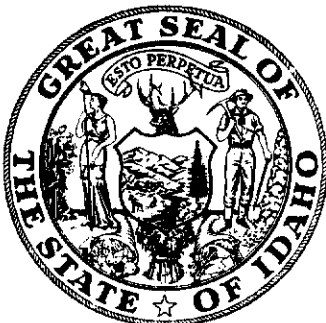

1. That we, being the Incorporators, the Directors and sole shareholders of ATB Freight Services, Incorporated, wish to reorganize and amend the Articles of Incorporation for this corporation.
2. Article 1 of the Articles of Incorporation of ATB Freight Services, Incorporated; which reads as follows:
 1. The name of the corporation is ATB Freight Services, Incorporated.

SHALL BE AMENDED TO READ:

1. The name of the corporation shall be: ATB Inspection Services, Inc.
3. Article 4 of the Articles of Incorporation of ATB Freight Services, Incorporated; which reads as follows:
 4. The general nature of the business to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and the extent as natural persons might or could do, in any part of the world, viz: To broker or otherwise arrange for the transportation of goods, services or materials via any and all legal means. To provide any support or services for consignor, consignee or any mode of transportation that may from time to time be required or desired.

The foregoing purposes and activities will be interpreted as examples only and not as limitations and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objects.

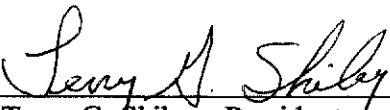

Except for the designated amendments, (Article 1 and Article 4) the Articles of Incorporation correctly set forth, without change, the provisions of the Articles of Incorporation for this corporation. Together with the Amended Article 1 and the Amended Article 4, the remaining original Articles of Incorporation will supersede the original Articles of Incorporation and become the Amended Articles of Incorporation.
