**ARTICLES OF INCORPORATION  
OF  
RIDGLEY ENTERPRISES INC.**

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

**ARTICLE I.**

The name of this corporation shall be RIDGLEY ENTERPRISES INC.

**ARTICLE II.**

The period of existence and duration of the life of this corporation shall be perpetual.

**ARTICLE III.**

This corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The total number of shares of the corporation shall consist of 100 shares of Common Stock having a par value of \$1.00 per share for a total value in stock of \$100.00, all of one class denoted Common Stock, each share being entitled to one (1) vote.
