The voluntary application, duly verified, having been filed in the above-entitled Court in the above-entitled matter on December 12, 1973, by Avco Financial Services of Blackfoot, Inc., a corporation, and its directors praying that Avco Financial Services of Blackfoot, Inc., be dissolved, and having been presented to the Court on the 11th day of March, 1974, on this matter; and the Affidavit of James R. Gillespie having been presented to the Court;

It appeared to the Court from said application and the records and files in this matter, and the Court so finds, that the application was filed in this Court on the 12th day of December, 1973, an order was duly given, made and entered on the 18th day of December, 1973, directing that said application be filed with the Clerk of this Court and that

said Clerk give not less than thirty (30) days' notice of such application by publication in the Blackfoot News, a newspaper of general circulation printed and published in Blackfoot, Bingham County, Idaho; that notice has been given and published as required by said order and by the statutes of the State of Idaho in such case made and provided, and the time for such publication has expired and that no objections have been made or filed to said application, and the time allowed by law by said order and notice for filing of such objections has expired.

It further appearing to the Court that the allegations contained in said application are true, and that all the claims and demands against said corporation have been satisfied and discharged, and that said corporation should be dissolved as an Idaho corporation;

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

(1) That Avco Financial Services of Blackfoot, Inc., a corporation heretofore organized and existing under and by virtue of the laws of the State of Idaho shall become, and the same hereby is, dissolved.

(2) That H. W. Merryman, Philip J. Cullen and Herbert F. Smith are the directors of the affairs of said corporation with full power to settle the affairs of said corporation and to distribute and convey all of the property of said corporation to its shareholders in settlement of its affairs and the complete liquidation of the corporation.
