ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

- FIRST:** The name of the corporation is Carbon Company, Inc.
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, and in addition, the manufacturing, and marketing of Environmental Remediation Materials.
- FOURTH:** The aggregate number of shares which the corporation shall have the authority to issue is 100,000 at a par value of \$1.00.
- FIFTH:** Provisions denying preemptive rights are none.
- SIXTH:** Provisions for the regulation of the internal affairs of the corporation are none.




